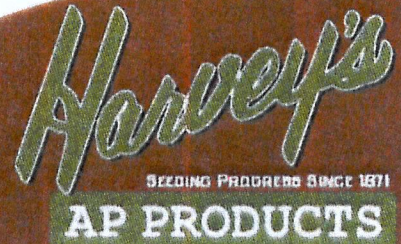

### FIRST AID

**IF IN EYES:** Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lens, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control center or doctor for treatment advice.  
**IF ON SKIN OR CLOTHING:** Call a POISON CENTER or doctor / physician / seek medical attention if you feel unwell. Take off contaminated clothing and wash it before reuse. Wash with plenty of soap and water.

### GENERAL INFORMATION

AP BLEND PRO is a water-conditioning agent, that is formulated to enhance pesticidal performance. Hard water cations and high pH can decrease mixability and solubility of certain pesticides. AP BLEND PRO contains buffering and chelating agents which aid in maintaining the right pH in the tank mix solution and block hard water cations from interacting with the pesticide molecule.

### DIRECTIONS FOR USE

Add 2 to 3 quarts of AP BLEND PRO per 100 gallons of spray water (0.5 – 0.75% v/v). Note: AP BLEND PRO does not replace the need for a crop oil concentrate or nonionic surfactant. For specific rates of a COC or NIS, always refer to the pesticide manufacturers' label. Prior to use, read and follow all directions on this label and on the label of the pesticide being used. The pesticide manufacturer's label for specific usages and restrictions have precedence over DIRECTIONS FOR USE referred to on this label

### MIXING

All spray mixing and application equipment must be thoroughly cleaned before pesticides are applied.

1. Fill spray tank half full of water and start agitation.
2. Add desired rate of AP BLEND PRO to water before adding pesticides
3. Add pesticides as directed by the label, while maintaining agitation.

### STORAGE AND DISPOSAL INFORMATION

**STORAGE:** Store product in original container only. Do not allow other chemicals to be introduced into the container. Do not use, spill, or store near heat or open flame. Keep this container closed when not in use.

**DISPOSAL:** Do not contaminate water, food, or feed by storage or disposal. Triple rinse container and pour rinsate into spray tank. Do not reuse container. Recycling decontaminated containers is the best option of container disposal. The Agricultural Container Recycling Council (ACRC) operates the national recycling program.
